TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT ("Trademark Assignment"), is entered into as of October __, 2015, among CircuitCity.com Inc., a Delaware corporation ("CircuitCity.com"), Circuit City Stores West Coast, Inc., a California corporation ("Circuit City West Coast" and collectively with CircuitCity.com, the "Assignors") and C&R Holding Group, Corp., a Delaware corporation ("Assignee").


WHEREAS, Assignee is hereby acquiring from Assignor all of Assignor's rights, title and interest to and under the "Circuit City" and "The City" and related trademarks (which includes all existing and all pending registrations and/or renewals thereof) as set forth on Exhibit A and all goodwill associated with such trademarks (collectively, the "Marks").

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, the parties hereby agree as follows:


1. Assignment. Assignor hereby assigns, conveys, and transfers to Assignee, and Assignors received, all of Assignors' rights, title, and interest in, to and under the Marks, including all associated goodwill and the right to sue for collected damages for infringements and past infringements thereof.
2. Recordation. The parties agree that this Agreement may be recorded with the United States Patent and Trademark Office (the "PTO") or other governing authority, and similar offices and authorities in jurisdictions other than the United State, and the parties hereby authorize the PTO, and such offices and authorities in jurisdictions other than the United States, to record this Agreement.
3. Further Assurances. From time to time after the Closing, without additional consideration, Assignors hereto will execute and deliver such further instruments and take such further action as may be necessary or reasonably requested by Assignee to effectuate the assignment and transfer of the Marks.
4. Attorney in Fact. Assignors hereby appoints Assignee as its attorney-in-fact, with full authority in the place and stead of Assignors, and in the name of Assignors, solely to take any action and to create any instrument that may be necessary or desirable to register, effectuate, validate, record, maintain, perfect, enforce or defend this Agreement and Assignee's rights in the Marks.
5. Counterparts. This Trademark Assignment may be executed in any number of counterparts and by the different parties hereto on separate counterparts, each of which when so executed and delivered shall be an original and all of which shall together constitute one and the same agreement. Faxed or PDF signatures/confirmations shall be deemed sufficient for all purposes.
6. Governing Law; Venue. This Trademark Assignment will be governed by laws of the State of New York. Each party hereby irrevocably consents to exclusive personal jurisdiction and venue in the state and federal courts located in the State of New York, County of Westchester, with respect to any actions arising out of or in connection with this Trademark Assignment.




