

ASSIGNMENT

THIS ASSIGNMENT ("Assignment") is effective as of the 14 day of January, 2013 from David S. Derbes ("ASSIGNOR"), having an address of 308 S. 

This Assignment includes all statutory and/or common law rights for such Trademark, and any and all trade names, trademarks, and trade dress used therewith, and any and all rights to contest, protest or sue at law or in equity for any infringement, imitation, impairment, distortion, dilution or other unauthorized use or conduct in derogation of the Trademark, including the right to receive all proceeds and damages therefrom. This Assignment includes all rights to obtain registrations and/or renewals of registration or other legal protections pertaining to the aforesaid Trademark Application and Trademark.

ASSIGNEE, its successors and assigns, shall hold the rights to the foregoing for and during the existence of such Trademark, and all renewals thereof, as fully and as entirely as the same would have been held and enjoyed by the assigning party had this Assignment not been made.
